PRESIDENT'S REPORT ... October 2005

The Executive is pleased with the accomplishments of the past season – our 20th – and feel that we have had a banner year in many aspects of the program. We have been able to extend the work of previous Directors and continue the development of our playing schedule and management procedures.

Our primary objectives, beyond “...*the encouragement of good fellowship among our members and the promotion of golf ...*”, were twofold: firstly, we set out to present a golfing schedule that was interesting, enjoyable and offered a variety of experiences and rewards. Secondly, we were committed to operate the Club in a fiscally responsible manner. We feel that we have accomplished these objectives and have created an atmosphere and a platform that will facilitate the work of next year's executive.

Selected highlights of this year's achievements are:

- Restructuring of the Club's data base to facilitate communication.
- Revision of the admission requirements to accept applicants who have reached the age of 55 years and who play to a handicap index of 30 or less.
- Initiated a recruiting campaign that resulted in the acquisition of 26 new members.
- Circulated questionnaires to determine the degree to which our new members are adapting to the Club's operation, and to identify potential volunteer personnel.
- Restructured the composition of existing foursomes to accelerate the integration of our new members and to quickly introduce them to the “ways” of the Club. This involved the revision of many established foursomes and we thank those involved for their resilience and adjustment to this procedure.
- Effort was made to increase the number of members involved in the management of our competitions. To this end, we can report that more than 50 members responded to this initiative and volunteered their skills, time and energy
- Arrangement for Block Times for the duration of our stay at Langara GC.
- Addition of three new competition formats to extend the variety within our schedule of fixtures: the Bud Brown Eclectic, the Designated Ball and the McQuarrie Hunter Tankard events.
- Introduction of WPGC caps to help in our attempts to build a Club identity.

- Establishment of an e-mail network to further facilitate communication.
- Design and creation of a Club website (www.westpointgolf.org) to provide a ready access to information relating to most of the Club's operations.

Overall, it has been a year of significant and continued progress and I wish to commend the 2005 executive for their unstinting work on behalf of the Club.

Five of our current Directors have completed a second term in their office and will be standing down on November 2 - their performances deserve to be recognized. Here's to **Stan Lawson** and **Neil Brett Davies** for their outstanding contribution and leadership within the Captain's jurisdiction; to **Kris Guttormsson**, our Treasurer, for his meticulous management of our financial needs and responsibilities; to **Bill Johnson**, our past President, who has served us well through the contribution of his insight, wealth of experience and thoughtful comments to our deliberations. And a special thanks to **Hans Stausboll** for devoting an extra year, in an *ex-officio* capacity, to ensure that our Divot Dust's production continued. To them all – thank you for the two years of service that you have dedicated to the WPGC.

The remaining members of the Executive have also contributed significantly to the year's successes and will be returning to serve as the core of the executive group in 2006. We are in good hands as **Ray Dujardin, Andy Schmidt, David Haddleton, Ben Oxholm and George Dedrick** will form the nucleus of next year's Executive.

Finally, I would be remiss if we did not express our appreciation for the behind the scenes work of **Roy Moulton**, our Systems Manager, who oversees the computer tracking of our scores; **Michael Alms** who has excelled as our Tee Time Coordinator; and **Ab Miles** who ensures that all trophies are prepared for presentation at our year-end awards ceremony.

It has been a pleasure to work with you and serve as your president over the past two years. I consider it as an honour and take this opportunity to thank you all for your support of the Club's activities. I am looking forward to continuing my association with the 2006 Executive in the capacity of Past President.

The 2005 Season was one of many changes and it is to the credit of all members that they adapted readily to the changes and with their support we all had a great golfing year.

Last season ended with only 80 playing members, 20 short of our maximum playing roster of 100. After 10 members resigned and three transferred to associate status we were reduced to a playing roster of 67 before the 2005 season started. One of our playing members sadly passed on early in the year, further reducing the number to 66.

We launched an aggressive program to recruit new members with the enthusiastic support of several members who sought out and sponsored many likely candidates. The effort made by these members is gratefully acknowledged and we urge all members to follow their example next year – our future depends on keeping our roster of playing members at full strength. We also lowered the admission age to 55 in recognition of the lower ages at which people retire these days. As another measure we increased the use of computer technology to handle the administration of all membership activities. The program as a result of these initiatives was successful in recruiting 26 new members to bring the number of **playing members to 92**. In other words the core membership of 66 at start of season was increased by 39% through the influx of new members! It is to the credit of the Captain and his Vice Presidents that existing foursomes were all re-arranged to accommodate the new members compatibly.

This season we welcomed John Santos, a visiting member from Western Australia's Carramar Club which in many respects is similar to our Club. John was visiting his son here for three months. We are open to these kinds of arrangements so keep this in mind if you know of any long-term visitors that are qualified to join us.
