MINUTES OF THE 77<sup>th</sup> ANNUAL GENERAL MEETING HELD ON  
 WEDNESDAY, NOVEMBER 7, 2007  
 AT THE ARBUTUS CLUB, 2001 NANTON STREET, VANCOUVER, B.C.

WELCOME and CALL TO ORDER: Ray Dujardin - acting as President and Chairman - called the Meeting to order at 11:35 a.m. and welcomed the members. He delivered introductory remarks – essentially a summary of his Annual Report.

QUORUM: The Chairman reported that there were 77 members present and that, as 8 members would constitute a quorum pursuant to the Constitution, a quorum was present.

MINUTES: The Minutes of the 76<sup>th</sup> Annual General Meeting having been printed in the Divot Dust, it was moved by Al Williams, seconded by David Thomas and unanimously resolved that the reading of the Minutes be waived and that they be approved and accepted.

ANNUAL REPORTS: The Annual Reports of the Directors (except the Secretary) having been published in the Divot Dust, it was moved by Dave Fairweather, seconded by Al Williams, and unanimously resolved that the reading of the Reports – other than the Treasurer’s - be waived and that the said Reports be accepted.

TREASURER’S REPORT AND FINANCIAL STATEMENT: In the absence of Fred Griffin Mr. Dujardin presented Mr. Griffin’s Treasurer’s Report and Annual Financial Statements. He noted that the Club in the year ended November 30, 2007 had revenue of \$10,386 and expenses of \$9,310, as a result of which the Club realized a surplus for the year of \$1,076, and has funds on hand of \$7,746. Copies of the Report having been circulated to members, it was moved by Jim Mackie, seconded by Gordon McCulloch, and unanimously resolved, that the Report be accepted and that the Financial Statement be approved..

ELECTIONS: The Chairman of the Nominating Committee, Gary Sinclair, presented the slate recommended by the Nominating Committee for election as Directors and Officers for 2008, being:

There were no nominations from the floor. It was moved by Al Williams, seconded by Dave Fairweather, and unanimously resolved that nominations be closed and that the Committee's nominees be elected as the Directors and Officers of the Club for the ensuing year.

EXECUTIVE APPOINTMENT - made by the President.

Gary Sinclair – as Past President (George Dedrick having advised that his illness will prevent him from serving as Past President), Editor-Divot Dust and Webmaster.

OTHER BUSINESS: There was discussion, initiated by Hugh Marshall, of the problem of members not recording all of their scores for games played during the golfing season. Mr. Selley responded reporting on steps that had been taken by him at the direction of the Board following the end of the Vancouver City strike – and stated his conclusion that there were no significant numbers of members who had not recorded scores. He advised that, for 2008, Foursome Captains will be mandated to ensure that their members' scores are posted either on their own computers or with the help of Roy Moulton.

Hugh Marshall rose to ask the members present to join him in applauding the efforts of the Board of Directors for the past year and, in particular, the efforts of the Captain (Jim Selley) and Vice-Captain (Duncan MacInnes).

In contrast to last year, when normal play was disrupted by the civic strike, the Club enjoyed a full season of play with few departures from the schedule. Good weather has enabled members to play under ideal conditions most of the time. The feedback I get is that great fun was had by all and that members really appreciated playing golf in the friendly yet competitive atmosphere fostered by the Club. These sentiments are very encouraging to those that now, and in the past, have managed the Club's affairs and organized events – it makes it all worthwhile!

The Board of Directors met monthly throughout the year at Brock House. Minutes were ably kept by *Carl Jonsson*, Secretary and will be filed in the Club archives at the B.C. Golf Museum. There were always many items to discuss and plans to be made to the extent that

the two hours of allotted meeting-time were fully utilized every time!

During the year, your Board had cause to debate all of the options open to the Club regarding where and which day to play, the limit on the number of playing members and whether to allow play from other-than the white tees. *Dave Stephens*, Director at Large prepared a very well written review of these issues. Following distribution of the review on October 13th the members had their say at a special meeting held on October 23rd at the Langara Clubhouse. The whole purpose was to provide guidance for the incoming Board of Directors when it considers the Club program for 2009 and beyond. Fifty-three members attended and eight who could not attend expressed their views directly to the Captain. Following an excellent presentation by the Captain, by show of hands the majority views of the membership were made known on all four main-issues and will be summarized in the minutes of the meeting to be distributed later. Thank you to the organizers of this stimulating event and to all members that attended.

Throughout the past year our Captain and his associates at the Captain's Table served us well indeed. Thanks to the hours expended by these men everything went smoothly. Behind the scenes a lot of work, often frustrating when cancellations occurred, was involved in setting up the weekly tee-times. Our amiable and popular Vice Captain, *Duncan MacInnes* took this on until cancer struck and he had to pass the job on to Captain *Jim Selley*. We thank both Jim and Dunc for their dedication to the task. Needless to say all of us have Dunc in our thoughts and prayers as he continues the battle. From talking to members, I know that many of you have also had first-hand experience with cancer and appreciate what Dunc is going through.

Playing membership reached our maximum of one hundred and at season-end there were seventeen golfers on the waiting list. Our Membership Director, *Jim Appleby* did a great job managing the applications and ensuring the roster was kept at a maximum. You may have played with some of the prospective members when they made up a foursome. Many are members of the Men's Mid Week Golf Club who have been prompted to apply for membership due to uncertain times at the University Golf Club.

*Jim Mackie* will report on the Club's social activities separately. I just want to say thanks to Jim for looking after this aspect of the Club program so well. The change to having all events at Langara was very well received and in particular the Palcutta proved to be a real fun evening in a bright and comfortable atmosphere. The good attendance at all events was testament to the right choice of venue.

Thanks are also due to our Treasurer, *Brian Ciccozzi* for looking after our Club finances in such a professional (and comprehensible) way. His report and 2009 budget will show that our financial position is very sound – thanks to some good fiscal management now and in past years. Annual dues will again remain at \$100 which must be the best deal in town!

It would also be remiss of me not to acknowledge the fine work *Gary Sinclair* puts into the design and maintenance of the West Point website and the production of *Divot Dust*. These means of graphic communications have contributed so much to enabling members to keep in personal touch with what's going on and to really feel part of our inclusive Club. Thanks are also due to *Roy Moulton* who takes care of mailing *Divot Dust* and other communications to members who have no computer. Roy also looks after our computerized handicap records which is of course is fundamental to our ability to play competitive golf on a fair basis.

At the conclusion of the AGM on November 12<sup>th</sup> I will hand over the President's gavel to my successor. I filled-in as President for the last few months of 2006 when *George Dedrick* became sick and then served the Club during the succeeding two years. My job has been made easy by a most able and supportive Board of Directors all of whom performed their roles diligently. I have enjoyed getting to know you the members more closely and your frequent words of encouragement and appreciation. ## CAPTAIN'S ANNUAL REPORT 2008

It seems like yesterday that we started the season, but here I am writing my final report for the *Divot Dust* signaling the end of the 2008 season. How quickly time passes. I would like to start this report by thanking our President *Ray Dujardin*, the Board and all the members of the Captain's committee for the support and help during the season. In my view, West Point had a wonderful season for a number of reasons, some of which I will expand upon below.

The season got off to a rainy beginning, but improved quickly as did the golf scores. The number of members playing each week increased materially from last year, reaching a peak of 88 players during May, while averaging 80 players through much of the season. We were able to run all our competitions as scheduled, with only two (the final Away Game and the 4 – ball) being cancelled due to a lack of interest. I expect we will re-think and modify these two events next season.

Looking at the par points and low nets scores each week, it suggested to me the high level of competition that exists in the club. Of note, we had a gross 69 by *Peter Coyle* and a net 55 by *Dave Thomas* -- the lowest scores I am aware of ever being recorded during club play. This competitiveness certainly proved true as well in the results of our many competitions, including the interclub match with the University Club, which West Point won for the second year in a row.

Scheduling of our games each week at both McCleery and Langara went off without a hitch and we received excellent co-operation from the Pro Shops and course staff. In return, the members lived up to our commitment to "pace of play" such that this issue should no longer be a concern to the club or the golf courses. I would like to extend my appreciation to all members for their efforts in this regard and ask them to continue to do so for the next Captain. I would also like to remind members of the three reasons why the golf course staff at McCleery & Langara appreciate having our club as customers:

1. We play rain or shine;
2. We maintain the golf course (fix divots and ball marks);
3. We self-enforce "pace of play".

I think we must continue to remember these attributes that make us valuable clients.

As noted above, we continued with a home and home interclub match with University Mid Week Men's Club. I would like to single out the contribution of *Brian Ciccozzi* to the success of this event. Frankly, Brian organized this competition from a West Point standpoint and made my job very simple ..... just hand out the prizes and accept the winner's trophy on behalf of the club.

I would like to thank the membership for the large turnout to the Special Meeting held in October and the positive feedback provided to the Executive on the views of the membership. I think the meeting has provided the next Board with solid direction on the wishes of the membership. Thanks, again, to all members who attended and / or expressed their views.







## COMMUNICATIONS

### COMMUNICATIONS REPORT 2008

Our “media” outlets appear to be providing for the Club’s communications needs quite well as they attempt to alert the membership to forthcoming events as well as to report and record the results of completed events. The Divot Dust has done this quarterly whereas the website provides our relevant information updates on a weekly basis.

The website continues to grow in terms of its importance as reflected by the user traffic numbers recorded by our service provider. For the record, last year’s total of 5369 membership visits has increased to 6559 visits for this year. The 2007 total of 21,485 pages viewed has swelled to 27,485 during our 2008 season. Not surprisingly, the pages most frequently “hit” are, in order, (1) tee times (2) current events (3) weekly prizes (4) handicap rankings, and (5) members gallery.

The website is now definitely established as our “go to” information source and it’s scope, flexibility and timeliness is beginning to render the Divot Dust, as we know it, redundant. The future of the traditional type of newsletter, in the electronic age, will be visited over the coming year and your feelings regarding it’s form will be sought.

Although the site is well established, it is still regarded as being “under development” as new elements and various changes are constantly being considered. This year, in response to a number of requests, a link to our handicap ranking site was provided. The coming year will see an improved access to our archival information as well as a more appealing presentation of each of our competition fixtures and their respective rules of play.



## A RULES REFRESHER

### DAVE FAIRWEATHER

CHARTER MEMBER -WPGC

To recap: In our August issue I took issue with the British Open's officials' application/interpretation of Rule 18-2b during the high winds and their effect on balls on a few of the greens.

Rule 18-2b – Ball Moving After Address. *"If a player's ball in play moves after he has addressed it (other than as a result of a stroke), the player is deemed to have moved the ball and incurs a penalty of one stroke. The ball must be replaced".*

Opening with this quote from the Forward of the "good book" - *"The Rules of Golf should be faithful to their historical principles; must also be clear, comprehensive and understandable with penalties that are appropriate"*. I asked Brent McLaughlin, of the RCGA:

*"How can it be considered to be fair and appropriate when a player on the putting green under strong wind conditions will be subject to a penalty of one stroke if the wind moves the ball after he has taken his stance and grounded his club, before he can commence his stroke?"*

Then, I asked if *"...any action to review this Rule 18-2b is being considered. Many of us believe that in the circumstances indicated, this Rule is contrary to the spirit and intent of fair play and that it deserves a good look."*

Here is Brent's reply:

*David,*

*Although the Rules are continuously reviewed by the Joint Rules Committee, there are no immediate plans to revise or modify Rule 18.*

*I appreciate your thoughts and although seemingly harsh, the Rule as stated allows a player to alter his routine rather than risk penalty - a player is only penalized after he has addressed his ball - which means taken his stance AND grounded his club. Many players will not ground their club for this reason - especially under these extreme (windy) conditions. Processes such as those outlined in Rule 18 are there to protect all players (and the field) from players. One of the great traditions of the Rules of Golf is that (unlike many sports), there is not a lot of grey areas - or judgment calls...we need to preserve this aspect.*

Now: I, and others with whom I have spoken still feel that *Rule 18- 2b: Ball Moving After Address* - in strong/gusty wind conditions, when on the putting green, deserves special treatment. There should be no penalty, but the ball must be replaced.

I'm not sure what Brent means by *"allows the player to alter his routine rather than risk a penalty"*. I can only think he is suggesting that in such wind conditions, the player would be well advised not to ground his club at address, before making the backward movement of his putter. *This, to me, is not golf as it should be played.*

To wrap this one up, I think it can be said that while the skill and competitiveness of golfers will vary greatly, in playing the game, honor and integrity shall never be compromised, *nor should a player be penalized unfairly.*

- If you inadvertently move the ball with your putter while preparing to take the address position, take your lumps and the one stroke penalty.
- Should you be at the address position with the club grounded and a gust of wind moves the ball, it's a one stroke penalty, by the present rules.

*For goodness sake, be alert enough to quickly move your feet out of the way of the moving ball, because if it hits your shoe, under Rule 19-2 you add another penalty stroke.*

Golf was once a simple game. It's time for a holiday - hope you have a good winter.


