MINUTES OF WEST POINT GOLF CLUB
93rd ANNUAL GENERAL MEETING,
Tuesday November 7, 2023

1. Call to Order at 11 AM
2. Buffet Lunch served table by table
3. Trophy Presentations: Captain Bill Titmuss announced the winners aided by Mike Fryzuk and Roger Barnes; photos were taken by David McMurdo. This was somewhat chaotic in order to keep on time.
4. The 50/50 Ticket Draw was performed. Half of the monies collected plus extra from the membership fees are donated to the Inner-City Golf for Kids program.
5. The President, Ross Cassie, took over and made a number of points (eg., filling spots at Riverway) and thanked many people including the Board of Directors, the staff at the Arbutus Club. He then went on to welcome the members in various categories, regular, new, life, honorary, etc. There was a moment of silence for members recently passed, or in palliative care. He then went on to discuss the changed order of courses, which is working well by all accounts. He then thanked a number of the Board Members for their service and announced that David McMurdo and Basil Quan were stepping down from their respective portfolios.
6. The President then called for Quorum, which was confirmed.
7. John Evans, the Treasurer gave his report, and concluded that the Finances of the West Point GC are in exceptionally good shape. John spoke on the 2023 expenses and 2024 budget, referencing copies of a spreadsheet provided on the tables (Appended). Expenses for 2023 came in well under budget. The proposal for 2024 will keep planned expenditures very similar to last year with a small expected surplus. **The 2024 budget was then approved by the membership.** A second motion was made to waive the external audit, which was passed.
8. John Dawson, Past President, presented the results of the Nomination Committee; he also asked if there were any nominations from the floor, and as none were declared, the continuing and new board members were proposed in a motion, seconded and passed.

One of our goals this year was to insure that we were filling the allotted tee times that we had at our Vancouver courses and Riverway. The fact that in many weeks we were over-

subscribed indicates we have been very successful in achieving this but we are still dealing with the problem of late cancellations. In 2025 the VPB has informed us that they are going to be implementing their 4-hour cancellation policy more diligently than in years past.

Our tournaments this season were very competitive and there was lots of variety in the tournaments. Many thanks to our Club Captain, Bill Titmuss, for all of his work with our tournaments. Bill is never idle with his plans on how we can improve our competitions. Bill will be moving on from the Captaincy and I would like to thank and acknowledge Bill for all of his work in this role.

This year we used the same order we played the 3 Vancouver courses as well as the amount of time we played at each course. Starting with Langara allows us to take advantage of the excellent drainage at the course. By starting later in our season at McCleery, that course is much drier to play than if we started earlier. Given the back 9 of McCleery, we need all the help we can get! Again this year, our club was able to maintain excellent relations with the Pro Shop staffs at Langara, McCleery, Fraserview and Riverway.

Our full membership numbers are currently at 119. We still have a very active wait list. This year because of the large numbers of people who joined our wait list we created two wait lists. The Active Wait List had 20 individuals on it at the beginning of the year and the Pending Wait List started with 14 individuals. The Pending wait listers will have first crack at joining our Active wait list for 2025. A draw was used to determine which wait list our prospective members were placed on. Our new members and our current wait list members are very active in our weekly games and this is great to see. We are certainly a well known and popular club to be a member of. Again this past winter we offered tee times during the off-season to our members at Langara and Riverway. Many of our members who are not in the sunnier climates took advantage of these times. Thanks to Brian Montpelier for organizing our Langara days and to Jim Bones for our times at Riverway.

Speaking of Riverway times, most of the weeks during the season our 16 tee slots were full. We continued to use a sign up system that allows for as many members as possible to get tee times and this has proven to be successful. As well this year we were charged a non-refundable reservation fee of \$5.00 per player which is consistent with the VPB policy at Langara, McCleery and Fraserview. Thanks again to our Riverway Coordinator, Jim Bones, for organizing our Riverway times and to Chris Chatten for coordinating the booking fee.

We did hold a number of Away Games this season that club members were able to attend at 5 different courses. Attendance did vary at these events and we will again be offering Away Games as part of our Club Schedule next season.

The finances of our club are in a healthy state. Our club's Treasurer, John Evans, has done a terrific job in monitoring our finances and developing a prudent financial plan to insure the club is able to continue to offer many benefits to our members. John is stepping aside as the Club Treasurer this year. John has done a tremendous job as the Treasurer these past few years!

One of the goals of the Executive has been to enhance our Social Events for our members. In that regard, prior to his passing, our Social Coordinator, John Maclachlan, had organized

many events during this season which were well-received by our members including the New Members' Orientation, Opening Social and the Hugh Marshall tournament and social. Each week the Captain's Table under the leadership of Jeremy Marr, our Vice Captain of Scoring, does a great job of tabulating our scores and sending out the results to our membership in a most timely fashion. The amount of support I received from these individuals was most appreciated as was the advice and comments I received from the membership. 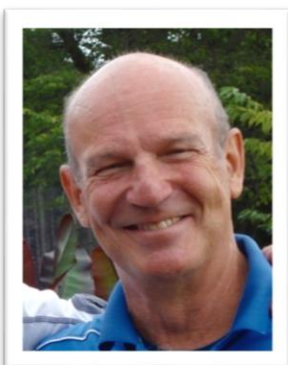

Captain's Report



Sign up: We changed the sign up times this season. Sign up opened three weeks ahead of a Thursday event. It did not close until the Sunday before the event at 12 noon. The final draw was not published until Monday morning. This was done to limit the number of last-minute cancelations. This seemed to help. We had less cancelations leading up to an event. Yet we still have members who do not look at the draw until they receive an email on Monday. Then they drop out of the draw leaving more work for the draw master. Most weeks we still had people cancel on the morning of an event due to illness or injury.

Captain's Table: Once again Jeremy Marr did an outstanding job of running the Captain's Table. If things seemed out of sorts, he took the time to carefully resolve any anomalies. He put more time into his work than most members fully understand. And of course, he would not have been able to do such a good job without the dedication of Roger Barnes, Peter Coyle, David Marr, Michael McSevney, Jim Bones, Richard Martin, and David McMurdo.

Wait List Members: With 20 men on the wait list, there was a great demand for tee times. Each week we were juggling moving Wait List members out of the draw as full members took their spots. Often a Wait List member would get back in the draw late in the week when a full-time member canceled. To simplify and make this fair to all we changed the procedure. Wait List members wait until the Friday before the event; if there is an open slot, a Wait List player may take that slot and be guaranteed he will not be bumped out of the draw.

End of the Year Survey

I looked at the sign-up logs for the entire year and entered the data with the dates for the Sunday before an event and the days up until the event on Thursday. I found there is a significant number of people that wait until they see the email sent out on Mondays by Alex to decide whether they will play that week or not. This of course creates more work for the draw master. I also found some members do change their sign-up status on Sunday mornings. This is what we hoped would happen. This is a cooperative action on our member's part. It helps clarify the draw in a timely manner.

Game Only Day: We included one "Game Only Day" into the 2024 schedule. It received good feedback from the membership. Opinions varied as to whether we should have one a month, one per golf course, or more. It will be up to the next Captain when he creates the 2025 calendar.

A Change in Members' Attitudes: With tee times being difficult to come by some of our newer members seem to just want a tee time and are reluctant to play in competitions, especially team competitions. This was demonstrated at the end of August with the Joe Dwyer Two Man Teams. Only 73 members played. A week later with the Roli Parker Eclectic, we had close to 90 members signed up to play.

This begs the questions: Why did you join a golf club if you are not willing to participate fully in what the club has to offer? Team events are one of the ways members get to know each other. We need to look at how to foster better participation in team events.

Away Games: Finding affordable away games has become very difficult. Thanks to our coordinators we were able to pull together five events. Tsawwassen Springs remains a good deal with senior rates. We used it at the beginning and end of the season. Craig Thomson led us to Kings Links. John Smart got us the newly renovated Squamish Golf Club. And of course, John Mathews and Joe Strasser rolled out another fun-filled day at Surrey Golf Club. Players stayed after their rounds to socialize at all the events. Thanks to all involved.

Club Championship: This event was simplified and moved up in the calendar to stay away from August vacation times. We still missed a few members who were away on golf outings at the time of the competition. The final matches were a good representation of each of our three flights.

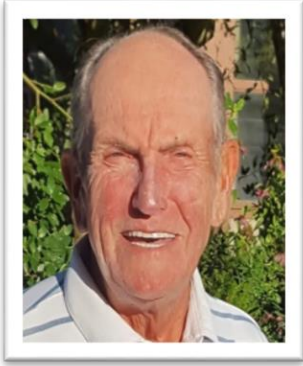
2024 Calendar: It worked well for the most part. It still can be tweaked. For instance, all team events could be preceded and followed by individual events. Of course, easier said than done if we want to keep traditional events on the calendar.

Two Years: My time as Captain has been rewarding and at times challenging. A big thank you to Ross Cassie, all the board members, and our membership for the support I have received. I think we have left the club in good shape.

Vice-Captain (Weekly Draw)



My priority as Vice Captain Draw (hereafter VCD) has been to try and fill our 80 spots per week for summer golf. The Vancouver Parks Board, as they continue to improve their computer systems, will be more diligent and relentless in maximizing revenues from golf. They are aware they can fill all of the spots even when it rains in Vancouver.

As a club enjoying benefits from the VPB, we must try and fill our allocated tee times.

2024 has been a poor year for accomplishing this objective. We have trouble filling almost every week. The attendance at Fraserview has been abysmal, even though the weather has been great.

I will redouble my efforts in 2025. I need the members' help to accomplish my goals.

At Langara, we filled 93 percent of our tee times and at McCleery 94 percent. But at Fraserview we have only filled 84 percent, an average of 13 spaces unfilled each week.

While sign-up sheets were full most weeks until mid-August, we had three or more unused spots in 21 out of 32 weeks this year. Attendance when the weather is iffy leads to 20 fair-weather golfers dropping out. Also, late cancellations must be minimized - it is too late for us to fill the space, so spots are unused, and another WP golfer who could have played is denied the opportunity.

Vice-Captain (Scoring)



As this is my third (and final) year as Vice-Captain – Scoring, it is natural that the various tasks of the position have become routine and easier. But there have been a few changes. Their support and diligence has been extremely reliable. Checking cards and entering scores is the primary function of the Captain’s Table. Lack of surnames is the primary failing. Just “Dave” does not work. At present we have 12

Dave/David in the club and 3 of them are Dave M.

Pace of Play has generally been good. I suppose that there will always be one person who is slower than everyone else. Too often, members of their group are too polite to say anything. I just hope that the slow players, when they are not keeping up with the group in front, recognize the enormous frustration of all the members who are waiting, and waiting, behind them.

The computer does most of the compiling of tournament results and they, typically, have been posted to the website Portal on Thursday evenings. There are still some challenges which the computer cannot handle – match play and handicaps related to age, for example. These results cannot be posted in the tournament results section but are posted in the *Useful Documents* section of the Portal.

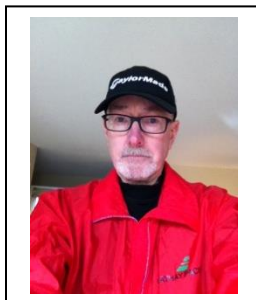
I would be remiss for not thanking Bill Titmuss, my Captain, for his help and advice – and patience. He really cares about the efficient operation of his mandate.

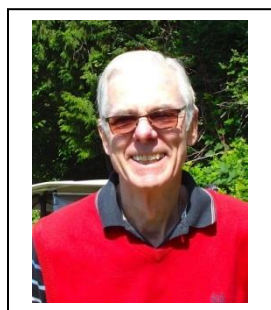

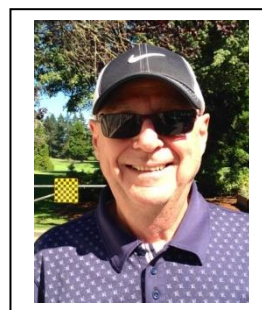

Membership Report



Interest in membership in West Point Golf Club continues to be very strong, with prompt renewals, few people leaving the club and very strong interest in joining the Wait List.

Renewals at the end of the 2023 season were typical in that only two full members did not renew. In addition, six full members changed to associates. This created the opportunity to promote five WLers to full membership in January.

As usual, a wait list opening was held early in January. A surprising 32 applications to join the wait list were received, twice the number in any recent year. This was much too many to add to the wait list, so a random draw was held to select 17 of the 32 applicants to join the wait list, with 15 others placed on a “pending wait list”, to have priority to be moved onto the wait list when space allows. To give the new Waitlisters a good introduction to the club, a “WLers Welcome” event was held the last Thursday before the regular season. This proved to be popular. Eleven WLers played with directors, followed by a welcome reception and meeting in the clubhouse.

It is important that the club uses its allocated tee times. Member turnout this season was strong, which meant tee-time usage each Thursday was very high through to August, with the keen 2024 WLers filling in any tee time gaps that did occur.

Full membership fell by four during the summer, with three members moving to Medical Leave and the unfortunate passing away of John Maclachlan. Hugh Marshall moving to Victoria led to a reduction in life members to three. With these declines in active member numbers, the Board approved seven new full members at the end of August. This season, promotion to full membership is based on participation, the number of games played with the club, not seniority, so the seven new members were the most active WLers, all playing ten or more games by end-August. 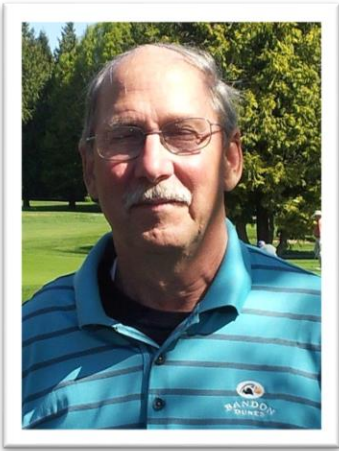

Handicap Report



Handicaps were reviewed periodically during the season. A few problems arose mainly for users of the Golf Canada system which uses extra adjustments, albeit rarely, compared to our software. We also removed a fair number of duplicate scores, mainly for members who forgot the Captain's Table does the posting for us.

Some tournaments, played over multiple weekends, caused some distress in posting scores to the handicap system – there were double postings and incorrect dates. The GolfSoftware Help Desk was useful in suggesting how best to post multi week tournaments in future to avoid errors.

Remember that posting scores for games played in B.C. is suspended between November 15 and February 28. However, if you are wintering where the sun shines all day (Arizona, California, Hawaii, Mexico) you must post your golf scores into our system at wp.golfclub.net.
